## Declaration of Compliance Detectable Safety knife (DOC-SK001)

We confirm that the pigmented polypropylene plastic used for the products listed above is in conformity with the applicable requirements of the following regulations and standards:

This compliance statement is based on information supplied by the polymer and pigment manufacturers/supplier, migration modelling and quality control systems in place for manufacture of the knife. Test condition for which migration restrictions are met = 2 hours at 70°C with all foods and food simulants.
